

## **Public offer to enter into a contract for participation in the International Forum Reaching Sustainable Development Goals in Combating Epidemics**

This document "The public offer to enter into a contract of participation" (hereinafter referred to as the "Offer ") in the International Forum Reaching Sustainable Development Goals in Combating Epidemics (hereinafter" the Forum ") is a proposal of "AIDS Infoshare" Foundation hereinafter referred to as the "Organizer," to enter into a contract for provision of services (hereinafter referred to as the "Contract") on the conditions set forth below with any person who accepts this offer (hereinafter referred to as the "Participant"). When mentioned jointly, the Organizer and the Participant are hereinafter referred to as the "Parties."

### **1. Procedure for entering into the Contract**

1.1. The Offer is considered accepted by the Participant and the Contract entered into by the Parties from the moment that the Participant performs the following actions:

1.1.1. Submission of an application for participation in the Forum in electronic form on the Organizer's website at: <http://sdg3forum.ru/>

The application is sent after reading the text of the Offer and activating the hypertext element (button) containing the inscription "I agree." An invoice will be generated upon submission of the application.

1.1.2. Payment by the Participant of the invoice by the specified deadline.

The Contract will take effect from the moment payment is received.

1.2. In accordance with clause 3 of Article 434 and clause 3 of Article 438 of the Civil Code of the Russian Federation, the written form of the Contract is considered fulfilled with if the person who received the offer by the established deadline performs necessary actions to fulfill the conditions of the Contract specified in the offer, Services of the Organizer.

### **2. Subject of the Contract**

2.1. The Contractor undertakes to organize the provision of registration and information/consulting services to the Participant (hereinafter referred to as the "Services") within the framework of the Forum on the conditions set forth below.

2.2. When the Participant submits an application for full-time participation in the Forum, the Services are provided at the venue of the Forum: Moscow, Krasnopresnenskaya Embankment, 12, World Trade Center (WTC).

2.3. The Forum will be held April 23-24, 2020.

2.4. The Forum program is available on the Organizer's website at: <http://sdg3forum.ru/> and can be changed at the discretion of the Organizer.

### **3. Cost of Services and Payment Procedure**

3.1. The cost of Services is indicated in the invoice based on the following tariffs:

- 3000 rubles/45 Euros/50 US dollars

3.2. The cost of the Services with full-time participation in the Forum includes the cost of informational materials and food and beverage provided during coffee breaks.

3.3 The cost of the Services with participation in the Forum does not include the cost of issuing a Russian visa or any customs payments (if necessary), travel, accommodation, meals or daily subsistence allowance.

3.4. The Participant undertakes to pay for the Services with full-time participation in the Forum by remitting 100% advance payment no later than April 3, 2020. Without advance payment, the Services will not be rendered to the Participant, and the Participant will be denied access to the Forum site.

3.5. Payment for the services is made by transferring funds to the account of the Forum, as indicated in the invoice.

3.6. The cost of the paid services is non-refundable, except for cases when the Organizer refuses

to provide the Services.

3.7. If the Participant declines to participate in the Forum after payment for the Services, the right to participate may be transferred to a third party. The relevant information with a written request for the re-registration of the provision of the Services by the Organizer to another person must be transferred to the Organizer no later than April 3, 2020.

3.8. In case of full-time participation in the Forum, the Act of Services rendered is transferred to the Participant through its representative participating in the Forum on the day of its completion.

3.9. The participant undertakes to sign the Contract on the day of receipt or to send written objections to the Contractor within the same period. In the event that the signed act or written objections are not received within the prescribed period, the Services shall be deemed accepted by the Participant in full without any reservations.

#### **4. Final conditions**

4.1. The Contract shall enter into force upon acceptance of the Offer by the Participant and shall remain in force until the Parties fulfill their obligations in full.

4.2. The Contract can be terminated in accordance with the procedure provided for by the current legislation of the Russian Federation.

4.3. In the event of non-fulfillment or improper fulfillment of their obligations, the Parties are liable in accordance with the provisions of the Contract and the current legislation of the Russian Federation.

4.4. The Organizer is not responsible for results of the Participant using the information received during the provision of the Services.

4.5. The Parties shall take measures to resolve all disputes and disagreements arising from the Contract or in connection with its execution through negotiations. The time for consideration of the claim is 30 (thirty) days from the date it is received by the Party.

4.6. In the event that it is not possible to resolve disputes and disagreements through negotiation, such disputes and disagreements shall be considered in the court at the location of the Organizer.

4.7. By concluding the Contract, the Participant freely, with his will and in his interest, gives irrevocable written consent for the use of any personal data specified in it or provided separately in connection with the conclusion and /or execution of the Contract, including an indication on the Contractor's website that is a publicly available source of personal Data, as well as other ways of processing such personal data, including any action (operation) or set of actions (operations) performed using automation tools or without using such means with personal data, including collection, recording, systematization, accumulation, storage, updating (updating, modification), extraction, use, transmission (distribution, provision, access), depersonalization, blocking, deletion, or destruction of personal data.

4.8. In the event that the Participant submits personal data to third parties, the Participant grants permission to use them in accordance with paragraph 4.9. and guarantees that the written consent of the said persons for such use has been received. The responsibility for any violation of this requirement in full is assumed by the Participant.

4.9. The Organizer reserves the right to carry out audio, video and photography in the framework of the Forum, which can be used for any purpose, including confirmation of Participant's participation in the Forum.

4.10. The Participant and their representatives at the Forum are prohibited from using professional audio, video and photography equipment during the Forum without the express written permission from the Organizer.

4.11. The Participant and their representatives at the Forum are allowed to use personal audio, video and photography equipment without the special written permission of the Organizer.

4.12. All notifications and other documents under the Contract shall be sent to the addresses indicated in the application relating to it and this Offer. Notifications and other documents in

writing are sent by registered mail or courier service (with confirmation of delivery); other messages can be sent by fax or e-mail.

4.13. For the duration of the Forum, participants are subject to the Rules for the location of the Forum. In case of non-compliance or violation of the rules, the Organizer reserves the right to refuse the Participant access to the events and remove the Participant from the Forum site.

4.14. Any Participant who is a foreign citizen must comply with the legislation of the Russian Federation.

4.15 The Parties are entitled at any time to formalize the Contract for the provision of Services on the terms of this Offer in the form of a single document signed by both Parties.
